<u>1.</u>	The Homeowner hereby gives The Sitter licence to enter upon and occupy the Premises for a period of days ("the Term"), beginning on ("the Commencement Date") and ending on ("the Vacation Date").	
<u>2.</u>	2. The Sitter agrees to enter The Premises on the Commencement Date, to live in and occupy the Premises for the Term of this agreement, and to vacate The Premises on the Vacation Date. The Sitters may be requested to extend their stay by	
<u>3.</u>	The Parties agree that no person other than The Sitter is permitted to live in or stay at The Premises during the specified Term or any part thereof, unless otherwise agreed to in writing by The Homeowner prior to the Commencement Date. Not withstanding this clause, The Sitter's permitted (name) is specifically permitted, with prior approval to accompany the Sitter for the duration of this house sitting arrangement.	
4.	The Homeowner agrees to allow The Sitter to occupy The Premises rent-free for the term of this

mutual agreement, in return for the care and upkeep of The Premises by The Sitter, together with

the carrying out of such other duties as are noted in the Schedule to this agreement.

- 5. As 'The Homeowner' and 'The Sitter' are receiving **no remuneration** they are not employees or contractors but volunteers, keen to enjoy the situation at 'The Premises' while providing a valuable service to (The Homeowner). A situation of mutual benefit has been created. In these circumstances (The Homeowner) will not recognise any claim for personal injury that may arise during the period in question. The Homeowner' would expect 'The Sitter' to carry their own insurance cover should they deem it necessary. 'The Sitter would expect 'The Homeowner' to carry their own Home Property and Contents insurance cover should they deem it necessary.
- <u>6.</u> The Homeowner agrees to make sure the residential premises are reasonably clean and fit to live in and the property and the animals are clear of infestations.
- 7. The Sitter agrees to take all reasonable steps in relation to the security, care and upkeep of The Premises, and to leave The Premises in a similar state of cleanliness and repair to that applying on the Commencement Date.
- <u>8.</u> The Homeowner agrees to make payment, either directly to the service provider or as a reimbursement to The Sitter for the following urgent repairs:
  - a. Burst water service
  - b. Blocked or broken lavatory system
  - c. Serious roof leak
  - d. Gas leak
  - e. Electrical faults
  - f. Flooding or serious flood damage
  - g. Serious storm damage
  - h. Serious fire damage
  - i. Failure or breakdown or the gas, electricity, or hot water to the premises
  - j. Failure or breakdown of any essential service for hot water, cooking, heating or laundering
  - k. Any fault of damage that causes the premises to be unsafe or not secure
- 9. The Homeowner agrees to pay The Sitter, within 7 days of the end of the house sitting assignment, any reasonable costs that The Sitter has incurred for making repairs to the premises so long as
  - a. The Sitter was not in breach of this agreement when the damage occurred
  - b. The Sitter gives the home owner, or their nominated contact, a reasonable opportunity to make the repairs
  - c. The Sitter makes a reasonable attempt to have any appropriate tradesperson named in this agreement make the repairs
  - d. The repairs are carried out, where appropriate, by licensed or properly qualified persons
  - e. The Sitter gives the home owner, or their nominated contact person, written details of the repairs, including receipts for any costs that the Sitter has occurred
- <u>10.</u> This mutual agreement may be extended by mutual agreement of The Parties, communicated either in writing, by telephone, or by email.
- 11. Nothing in this mutual agreement absolves The Parties from their statutory and common law duties and responsibilities, nor abrogates their legal privileges, rights and remedies in respect of the subject matter of this mutual agreement.
- 12. In the event that any dispute should arise in relation to this Housesitting mutual arrangement, The Parties agree to use their best endeavours to settle the matter in a fair and amicable manner.

- 13. In the event that The Homeowner is unable to return and occupy the premises on or after the agreed vacation date, The Homeowner is to provide (Attachment 1, Schedule), in this mutual agreement, full contact details of another party for The Sitter to handover the pet (s) and the premises to.
- 14. The Homeowner is to complete the Attachment 1, "Schedule", prior to the commencement of the House Sit.
- 15. This agreement is a mutual agreement and as no monies are exchanged other than for expenses in regards to costs incurred in the Housesitting assignment, this mutual agreement cannot be construed to be a legally binding contract and liabilities associated within contract law.
- <u>16.</u> It is expected that The Homeowner has property and contents insurance and that The Sitter has personal travel or related insurances.
